- 3. Article IV shall be revised as follows:

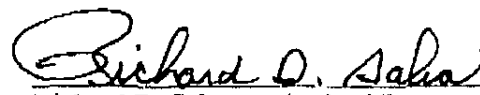

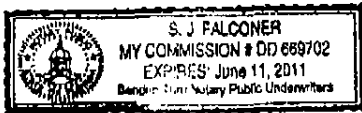

The undersigned subscribes to these Articles of Organization to form a limited liability company under the Florida Limited Liability Company Act.
