**ARTICLES OF ORGANIZATION
OF
COVE PARK LLC**

The undersigned authorized agent of the initial Member of the above limited liability company hereby certifies that the sole Member, for the purpose of forming a limited liability company under the laws of the State of Florida, hereby executes the following Articles to provide for the formation, rights, privileges, and immunities of a limited liability company for profit. The undersigned authorized agent further declares that the following Articles shall be the Charter and authority for the conduct of business of such limited liability company.

**ARTICLE I
NAME**

The name of the limited liability company shall be COVE PARK LLC (the "Company").

**ARTICLE II

This Operating Agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law, this Instrument and the Florida Limited Liability Company Act.


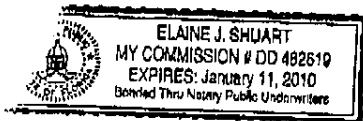
