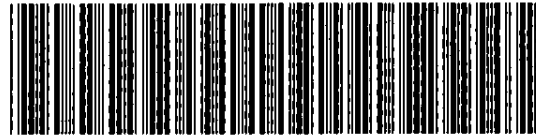

3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.



6. Management of the Company. The management of the Company shall be vested in the manager of the Company. The manager of the Company is Stephen J. Szabo, III


