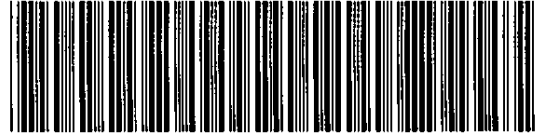

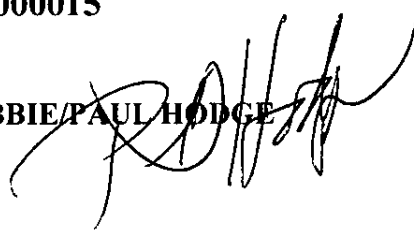

This Certificate of Conversion (this "*Certificate*") of TRECAP Partners LLC, a Florida limited liability company, is being executed and filed to convert the entity to a Delaware limited liability company under the Florida Limited Liability Company Act (the "*Florida LLC Act*").

1. Pursuant to the provisions of the Florida LLC Act, TRECAP Partners LLC, a Florida limited liability company (the "*Florida LLC*"), has been converted to a Delaware limited liability company under the name TRECAP Partners LLC (the "*Company*"). The conversion of the Florida LLC to the Company complies with the provisions of the Delaware Limited Liability Company Act.

6. The Company has agreed to pay any members of the Florida LLC having appraisal rights the amount to which such members are entitled under Sections 608.4351 – 608.43595 of the Florida LLC Act.
