**ARTICLES OF ORGANIZATION
OF
THE TFF, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I

NAME AND ADDRESS

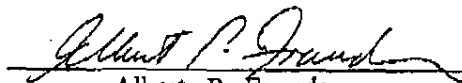
These Articles of Organization may be amended by a written instrument adopted by all of the members, or as may otherwise be provided by law.
