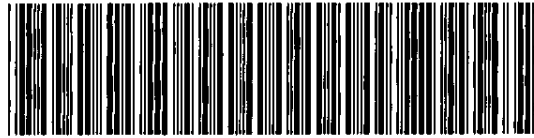


ARTICLE VI


