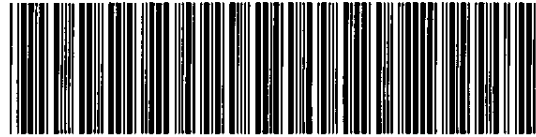

ARTICLES OF ORGANIZATION OF
TRANQUILITY HAIR & NAIL SALON, LLC

ARTICLE I
NAME AND PRINCIPAL PLACE OF BUSINESS

The name of this limited liability company shall be TRANQUILITY HAIR & NAIL SALON, LLC, and the mailing address and street address of its principal office shall be 880 Columbia Street, Port Charlotte, FL 33948, but it shall have the power and authority to establish branch offices at any other place or places as the members may designate.

ARTICLE II
PURPOSES AND POWERS

This limited liability company is organized for the purpose of engaging in any activity or business permitted under the laws of the United States and the State of Florida and shall have all of the powers authorized by the State of Florida for limited liability companies but shall remain subject to statutes and regulations of the laws of the State of Florida for regulating and controlling business.

ARTICLE III
MANAGEMENT

This limited liability company is to be managed by its members and the names and addresses of its managing members are:

ARTICLE IV
MEMBERSHIP RESTRICTIONS

The Members shall have the right to admit new members by unanimous consent. Contributions required of new members shall be determined as of the time of admission to the limited liability company.

A member's interest in the limited liability company may not be sold or otherwise transferred except with unanimous written consent of all members.

This limited liability company shall exist perpetually or until dissolved in a manner provided by law, or as provided in the regulations adopted by the members and shall commence its existence upon filing of these Articles.

ARTICLE VI AMENDMENT

These Articles may be amended by a vote of a majority in interest of the members.

ARTICLE VII INITIAL REGISTERED OFFICE AND REGISTERED AGENT
