

Model Articles of Organization for Bank or Trust Limited Liability Company

<u>ARTICLES OF ORGANIZATION</u>

YOAN MOREIRA ANTIQUE

ODEC M. S. The undersigned, being duly authorized to act as the organizer of this Limited Liab Company pursuant to Chapter 608 and Section 658.16, Florida Statutes, hereby forms a limited liability company under the laws of the State of Florida and adopts the following Articles of Organization for such Limited Liability Company.

ARTICLE I - NAME

The name of the limited liability company shall be YOAN MOREIRA ANTIQUE, LLC (hereinafter, the "Company").

In no instance shall the Company be automatically terminated, dissolved, or operations suspended upon the occurrence of an event, including the death, disability, bankruptcy, expulsion, or withdrawal of a member of the Company, other than the passage of time as may be specified by law or the Operating Agreement of the Company. Provided, however, that upon any such termination event, the existence and business of the Company may be continued by amendment of these Articles of Organization or the Operating Agreement providing for the continued existence of the Company as may be authorized by Florida Statutes.

<u>ARTICLE VI – MANAGEMENT AUTHORITY</u>

The exclusive authority to manage the Company is vested in a board of (managers or directors) that is (elected or appointed) by the members, which shall operate in substantially the same manner as, and has substantially the same rights, powers, privileges, duties, and responsibilities as, a board of directors of a (bank or trust) company chartered as a corporation.
