ARTICLES OF ORGANIZATION OF WILDWOODS CAMPGROUND, LLC.

The undersigned, under the provisions of Chapter 608 of the Florida Statutes (The "Act"), for the purpose of forming a limited liability company under the laws of the State of Florida, do set forth the following:

1. Name.

The name of the limited liability company is Wildwoods Campground, LLC (hereinafter referred to as the "Company").

2. Address Of Place Of Business.

7. Management.

The overall management and control of the business and affairs of the company shall be vested in its members, as provided in these Articles of the Organization and section 608.407 of the Act. The company is to be managed by the member/manager who is designated, appointed, or elected to act as the managing member.

8. Indemnification.

Except as expressly provided in the Operating Agreement, the company shall indemnify any member, manager, or former member or manager to the full extent permitted under the Act.
