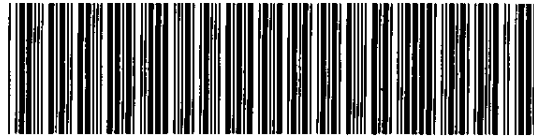

ARTICLES OF ORGANIZATION
OF
WILDWOODS CAMPGROUND, LLC.

The undersigned, under the provisions of Chapter 608 of the Florida Statutes (The "Act"), for the purpose of forming a limited liability company under the laws of the State of Florida, do set forth the following:

1. Name.

The name of the limited liability company is Wildwoods Campground, LLC (hereinafter referred to as the "Company").

2. Address Of Place Of Business.

The mailing address for the Company is 22113 State Road 40, Astor, Florida 32102 and the street address of the place of business for the Company is 22113 State Road 40, Astor, Florida 32102. These addresses may be changed from time to time as provided in the Operating Agreement.

3. Registered Agent.

The initial registered agent in Florida for the Company is David H. Rombach, and the initial registered office is located at 22113 State Road 40, Astor, Florida 32102.

4. Members.

The company shall have at least one member and may admit additional members on the prior unanimous written agreement of the then-existing members, or as otherwise provided in the Operating Agreement.

5. Period of Duration.

Unless earlier terminated under the Act or the Operating Agreement, the period of duration of the Company shall be perpetual.

6. Purpose.

The purpose for which the Company is organized is to engage in campground endeavors and any and all other business and activities permitted by the Act and any other applicable laws of the State of Florida. The Company shall have all of the powers vested in a limited liability company organized and existing by virtue of such laws.

7. Management.

The overall management and control of the business and affairs of the company shall be vested in its members, as provided in these Articles of Organization and section 608.407 of the Act. The company is to be managed by the member/manager who is designated, appointed, or elected to act as the managing member.

8. Indemnification.

Except as expressly provided in the Operating Agreement, the company shall indemnify any member, manager, or former member or manager to the full extent permitted under the Act.

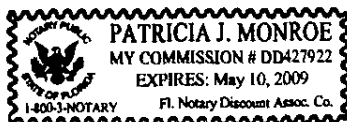
