ARTICLES OF ORGANIZATION

OF

ASAP RESTORATION LLC

The undersigned, for the purpose of forming a limited liability compared the Florida Limited Liability Company Act, Florida Statutes Chapter 608, makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME
