The Company shall be a manager-managed limited liability company. The Manager of the Company shall be Michael Maxwell.

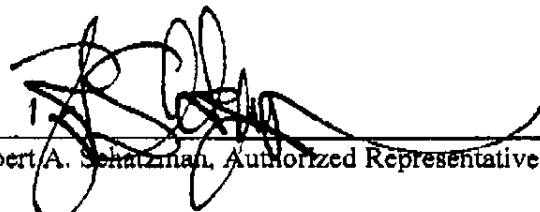

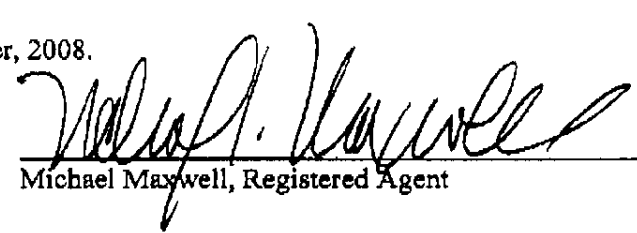
