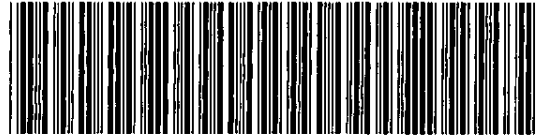

ARTICLE I
NAME

The name of this limited liability company is Kevin M. Barber, M.D., PLLC (the "Company").

DURATION
