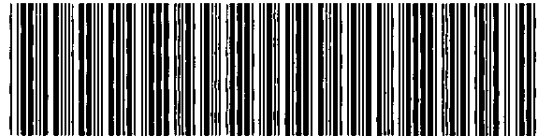

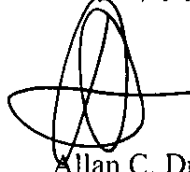

**ARTICLES OF ORGANIZATION
OF
DARNALL ENTERPRISES, LLC**

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes.

**ARTICLE I
NAME**

The name of this limited liability company is Darnall Enterprises, LLC (the Company).

**ARTICLE II
DURATION**

The existence of the Company shall commence on the filing of these Articles with the Florida Department of State and shall continue perpetually until the occurrence of any of the events specified in Section 608.441 Florida Statutes.

**ARTICLE III
PURPOSE**

The Company is organized for the transaction of any and all lawful business and activities.

**ARTICLE IV
POWERS**

The Company shall have all of the powers enumerated in the Florida Limited Liability Company Act.

**ARTICLE V
PRINCIPAL PLACE OF BUSINESS AND REGISTERED AGENT**

The street address and mailing address of the principal office and place of business of the Company is 1315 Delaney Avenue, Orlando, FL 32806 and the name and address of the initial registered agent of the Company is Diane S. Darnall, 1315 Delaney Avenue, Orlando, FL 32806.

**ARTICLE VI
CONTRIBUTIONS**

Contributions of cash or property may be made from time to time to the Company on agreement of all members.

ARTICLE VII
ADMISSION OF MEMBERS

Additional members may be admitted from time to time on the written consent of the Managing Directors of the Company.

ARTICLE VIII
TERMINATION OF MEMBERSHIP

If a member dies, retires, resigns, is expelled, is dissolved, experiences bankruptcy or on the occurrence of any other event that terminates the continued membership of the member in the Company, the remaining members by unanimous written agreement continue the business of the Company.

ARTICLE IX
REGULATIONS

The members may adopt, alter, amend or repeal regulations containing provisions for the management and regulation of the affairs of the Company, provided that such regulations are not inconsistent with the laws of the State of Florida or the Articles of Organization.

ARTICLE X
DISSOLUTION

The Company shall be dissolved on the occurrence of any of the following events:

- a. By the unanimous written agreement of all members;
- b. On the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or the occurrence of any other event that, under law, would terminate the Company, unless all of the remaining members of the Company consent in writing to continue the Company's existence; or
- c. On the occurrence of any of the events specified in Section 608.441 Florida Statutes.

ARTICLE XI
TRANSFER OF MEMBERSHIP INTEREST

No member may transfer his, her or its membership interest, or any part thereof, without the prior written consent of all of the other members of the Company.

ARTICLE XII
AMENDMENT

This limited liability company reserves the right to amend, alter or repeal any provisions contained in these Articles of Organization or any amendment hereto.

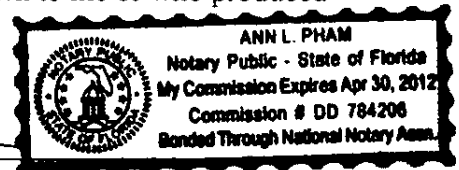
