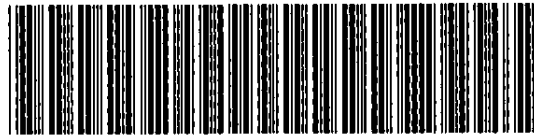

ADMISSION OF ADDITIONAL MEMBERS**

No additional members shall be admitted to the limited liability company except with the unanimous written consent of all the members of the limited liability company and upon such terms and conditions as shall be determined by all the members.
