**ARTICLE V. MANAGEMENT**

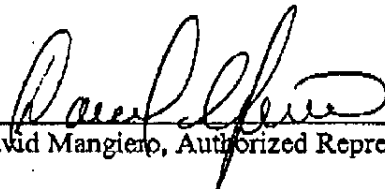
The Company shall be a manager-managed limited liability company. The initial Manager of the Company shall be Nicholas A. Mascioli.

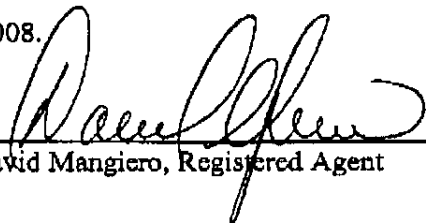
