

ARTICLES OF ORGANIZATION OF MILLENNIAL ARCHIVES, LLC

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

ARTICLE I - NAME

The name of this Limited Liability Company is MILLENNIAL ARCHIVES, LLC.

ARTICLE II - MAILING ADDRESS

The mailing address and street address of the principal office of MILLENNIAL ARCHIVES, LLC is 3281 Bridgehampton Lane, Orlando, Florida 32812.

ARTICLE III - DURATION

The period of duration for MILLENNIAL ARCHIVES, LLC shall be perpetual from the date of filing these Articles with the Department of the State, except for the limitations set out in Florida Statutes Section 608.441.

ARTICLE IV - REGISTERED AGENT & OFFICE

ARTICLE V - ADDITIONAL MEMBERS

MILLENNIAL ARCHIVES, LLC is to be managed by a manager and the name and address of the individual who will serve as the manager is:






