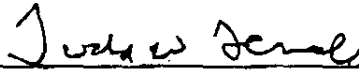
The Limited Liability Company is created to carry on a "real estate enterprise" within the meaning of Maryland Tax-Property Code § 12-108(bb)(1) and:

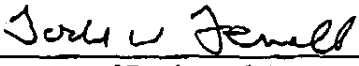
- iv. All real property owned by the individual members and used in the conduct of any real estate enterprise is being conveyed to the Limited Liability Company.
