SECOND: The Articles of Organization are hereby amended to insert a new Article I to read as follows:

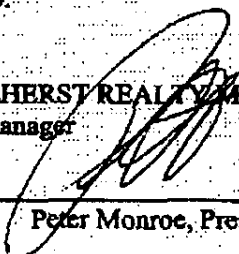
**"ARTICLE I
