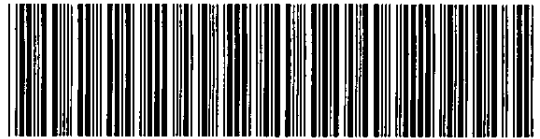

**Name.** The name of this Florida Limited Liability Company is **FRASER'S LAWN & GARDEN SERVICE, LLC.**





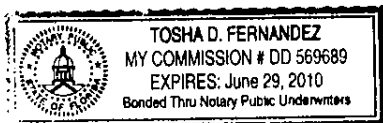
