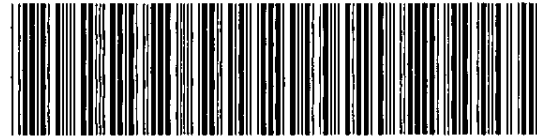

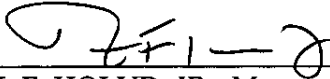
ARTICLE 6

additional members.

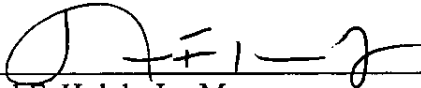

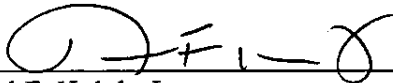
