ARTICLE V – DELAYED EFFECTIVE DATE

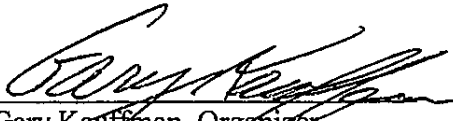
The Company’s existence shall commence on January 1, 2009 (the “Delayed Effective

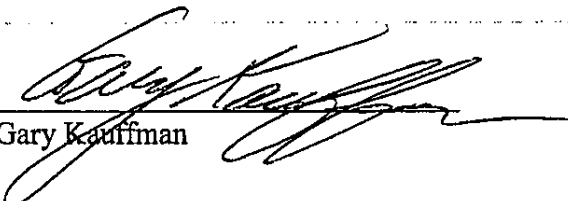
