**ARTICLE I
NAME**

The name of the Limited Liability Company (the "Company") is JAMY IMAGING, LLC.

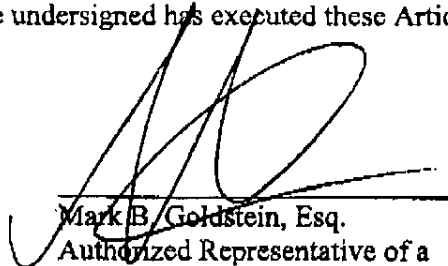
