

The undersigned, pursuant to the provisions of Chapter 608, Florida Statutes, provides the following information for the purpose of amending the Articles of Organization of **FIGG BRIDGE DEVELOPERS, LLC**, which was formed under the laws of the State of Florida pursuant to Articles of Organization originally filed with the Department of State on December 23, 2008, and assigned document number L08000116325.

1. Article 1 of the Articles of Organization is amended to read:

**ARTICLE 1.
Name**

*The name of the Limited Liability Company shall be **SOUTH NORFOLK JORDAN BRIDGE, LLC**.*

2. Pursuant to Section 608.4231, F.S., and in accordance with the Operating Agreement of the Company, the Members authorized and consented in writing on September 11, 2010, to this Amendment to Articles of Organization. The vote was sufficient for approval.
3. The Members hereby release the name of Figg Bridge Developers, LLC, for immediate use.

IN WITNESS WHEREOF, the undersigned has executed these Articles of Organization this 7th day of September, 2010.
