Articles of Organization

A Florida Limited Liability Company

- 1. Name. The name of this limited liability company is Scott White Advisors, LLC (the "Company"), and it shall be formed as a Florida limited liability company under Chapter 608, Florida Statutes.
- 2. <u>Effective Date</u>. The effective date of these Articles of Organization shall be January 1, 2009, and the Company's existence thereafter shall be perpetual.
