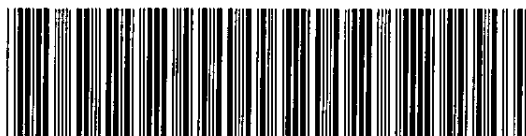





The name and street address of the initial registered agent are WILLIAM T. SPINNER and 10751 Alta Drive, Jacksonville, FL 32226.


**ARTICLE IV – MANAGING MEMBER**


