ARTICLES OF ORGANIZATION
OF
KANU MANAGEMENT COMPANY, L.L.C.
a Florida Limited Liability Company

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a limited liability company under the laws of the State of Florida do set forth the following:

ARTICLE I. NAME OF LIMITED LIABILITY COMPANY

The name is: KANU MANAGEMENT COMPANY, L.L.C., a Florida Limited Liability Company. (the "Limited Liability Company").

ARTICLE II. ADDRESS

Principal Office Address and Mailing address for the Limited Liability Company is: 604 Crandon Boulevard, Suite 205, Key Biscayne, FL 33149.

ARTICLE III. REGISTERED AGENT

ARTICLE V. DURATION.

The existence of the Limited Liability Company shall be perpetual, unless terminated by written agreement of the members, or by the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member, or upon the occurrence of any event which terminates the continued membership of a member, unless the existence and business of the company is continued by the consent and agreement of the remaining member(s) owning a majority of the membership in KANU MANAGEMENT COMPANY, LLC, or by amendment of these Articles of Organization by providing for the continued existence of the Limited Liability Company subsequent to the foregoing events.

ARTICLE VI. PURPOSE.

The purpose for which the Limited Liability Company is organized is to engage in any and all business and activities permitted by the laws of the State of Florida. The Limited Liability Company shall have all of the powers vested in a Limited Liability Company organized and existing by virtue of such laws.

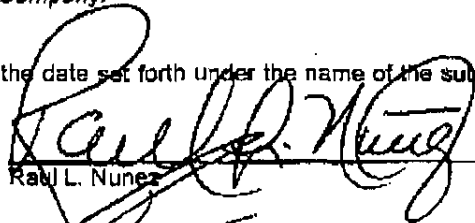
ARTICLE X.. ADDITIONAL CONTRIBUTIONS

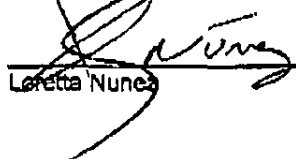
ARTICLE XI. OPERATION AND VOTING POWER

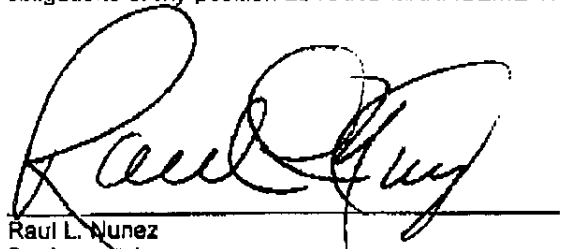
