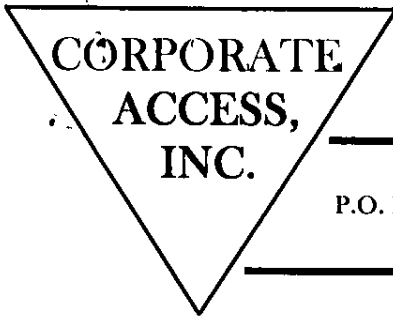


**ARTICLE IV

MEMBER'S RIGHT TO CONTINUE BUSINESS**


