




Article VI

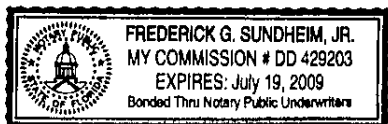
