## ARTICLES OF ORGANIZATION

### PRITCHETT MANAGER, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

#### ARTICLE I

##### NAME

The name of the limited liability company shall be Pritchett Manager, LLC (the "*Company*"). The mailing and street address of the principal office of the Company in Florida shall be 1050 SE 6<sup>th</sup> Street, Lake Butler, Florida 32054.

#### ARTICLE II

The Company shall not be dissolved upon the occurrence of any event that terminates the continued membership of a member in the Company, provided there is at least one remaining member. The Company shall be terminated and dissolved upon the consent of all of the members.

**MANAGER**




