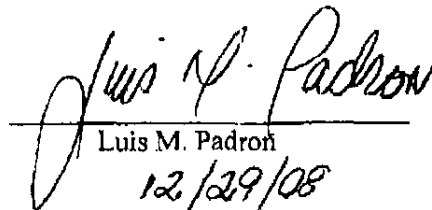

ARTICLE IV. - Nature of Business
