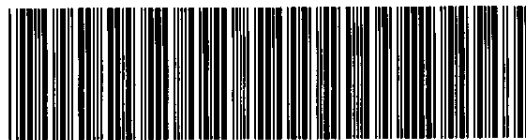

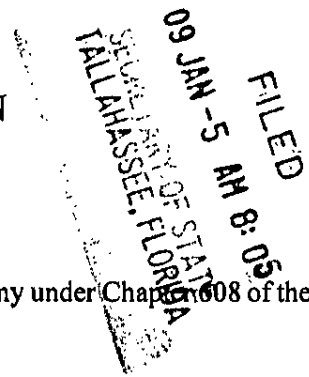
**ARTICLE IV. NATURE OF BUSINESS**
