# ARTICLES OF ORGANIZATION OF HUTCH ROBERTS, LLC

The undersigned, for the purpose of forming a multi-member limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby make, acknowledge, and file the following Articles of Organization.

#### ARTICLE | NAME AND ADDRESS

The name of the limited liability company shall be HUTCH ROBERTS, LLC ("Company"). The principal place of business of the Company in Florida shall be 4580 SE 36<sup>th</sup> Avenue, Ocala, Florida 34480.

### ARTICLE II DURATION
