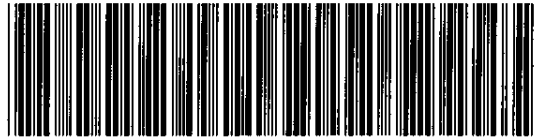



NAME




