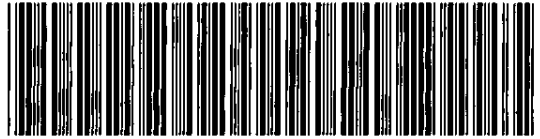



The undersigned, acting in accordance with Chapter 608, Florida Statutes (2007) (hereinafter referred to as the "Act"), for the purposes of forming a limited liability company under the laws of the state of Florida, does hereby set forth the following:

**ARTICLE I  
Name**

The name of this limited liability company shall be Heather Snyder Photography LLC (hereinafter referred to as the "Company").

**ARTICLE II

**ARTICLE V**  
**Purpose**

The Company is organized to transact and/or engage in any or all lawful business and activities permitted by the Act and any other applicable laws of the state of Florida. The Company shall have the powers vested in a limited liability company organized and existing by virtue of the Act and any other applicable laws of the state of Florida.

**ARTICLE VI**  
**Taxation**

For the purposes of federal and, if applicable, state income tax purposes, the Company shall be disregarded as an entity separate from its Managing Member for federal and state income tax purposes unless and until the Managing Member causes the Company to file an election to be classified as an association taxable as a corporation.

**ARTICLE VII**  
**Indemnification**

Except as expressly provided in the Operating Agreement, the Company shall indemnify and hold harmless any member, managing member, former member or former managing member against any and all claims and demands to the full extent permitted under the Act.

**ARTICLE VIII**  
**Capital Contributions**

Contributions to the capital of the Company shall be made by the members, in the manner prescribed by the Operating Agreement made and entered into by the members, and which may be amended from time to time in accordance with its terms.

**ARTICLE IX**  
**Effective Date and Period of Duration**

The Company shall exist perpetually, commencing at the date and time of filing of these Articles of Organization unless terminated earlier under the Act or the Operating Agreement.

In accordance with §608.408(3), Fla. Stat., the execution of this document constitutes an affirmation under the penalties of perjury that the facts stated herein are true.
