

ARTICLES OF ORGANIZATION

OF

DAY PLANNERS, L.L.C.

ARTICLE I - NAME

THE NAME OF THIS Limited Liability Company shall be **DAY PLANNERS, L.L.C.,**

ARTICLE II - ADDRESS
