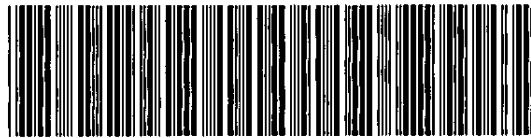

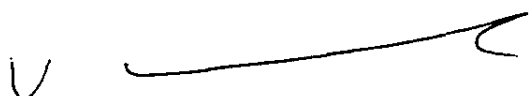
FIRST: This Articles of Amendment amends the Articles of Organization of **VLC Vacation Rentals, LLC, a Florida Limited Liability Company.**
