ARTICLES OF ORGANIZATION
FOR
FLORIDA DSD SYSTEMS, LLC

The undersigned, organizing Member of a Limited Liability Company to be formed under the Florida Limited Liability Company Act, as Amended (the "Act"), hereby forms a Florida Limited Liability Company (the "Company") pursuant to the Act, and hereby sets forth the following Articles of Organization (the "Articles"):

ARTICLE I

Name

The name of the Company is FLORIDA DSD SYSTEMS , LLC.

ARTICLE II

Commencement Date and Duration

The Company's existence shall commence on the date these Articles are filed with the Florida Department of State, and shall continue perpetually until dissolved in accordance with Section 608.441 of the Act.

ARTICLE III

Purpose

The Company is created for purposes of engaging in any lawful activity deemed appropriate by the members from time to time.

ARTICLE IV

Principal Office


The street address of the principal office of the Company shall be 2039 – 79th Street N.W., Bradenton, Florida 34209, and the mailing address shall be the same.

ARTICLE V

Registered Agent and Office
