

By virtue of a filing which took place on December 31, 2008, effective on January 1, 2009, Cynthia A. Kaleita, LMHC, Inc., a Florida corporation (Document Number P04000168741) was converted to Cynthia A. Kaleita, LMHC, LLC, a Florida limited liability company (Document Number L09000002191). The Federal Employee Identification Number (FEIN) of 20-2014729 which was assigned to the corporation should have automatically carried over to the LLC on the conversion date.

The LLC has electronically filed its Annual Reports with your office since the conversion. It has just come to our attention that the FEIN listed in your records for the LLC needs to be corrected. Apparently, when the corporation was converted to an LLC, the last two digits of the FEIN were transposed. Please correct the FEIN for the LLC to 20-2014729.
