

**ARTICLES OF ORGANIZATION  
OF  
CLEARWATER KAYAK TOURS, LLC**

The undersigned hereby forms a limited liability company under the laws of the State of Florida.

**ARTICLE I NAME**

The company's name is **Clearwater Kayak Tours, LLC.**

**ARTICLE II ADDRESS**

*mailing and principal place of business*  
The company's address is **2401 West Bay Drive, Suite 303, Largo, FL 33770.**

**ARTICLE III COMMENCEMENT OF EXISTENCE**

The Company's existence will commence **January 1, 2009**; provided however, that such date is within five business days prior to the date these Articles of Organization are filed by the Department of State of the State of Florida and shall continue in existence until dissolved. If such date is not within five business days of the date of filing, then the corporation's existence will commence on the date these articles of incorporation are filed by the Department of State of the State of Florida.

**ARTICLE IV PURPOSE, POWERS AND DEVELOPMENT FUNCTIONS OF THE LLC.**

Purpose, Powers, and Development Functions. The purpose of the LLC. shall be generally the operation of a kayak rental and tourism business.

1 Acquiring the personal property and business lease(s) necessary to carry on the business activities of the LLC.

2 Employing such personnel, and obtaining such legal, accounting, engineering, and other professional services and advice on behalf of the L.L.C. as the Manager(s) shall deem necessary or appropriate to carry out the acquisition, and development of the Projects and the business objectives of the LLC. on such terms, and for such compensation as the Manager shall determine to be appropriate in each circumstance;

3 Obtaining all permits and licenses which shall be necessary for the development of the various business opportunities;

4 To enter into and make all necessary contracts for its business with any person, entity, partnership, association, corporation, domestic or foreign, or of any domestic or foreign state, government, or governmental authority, or of any political or administrative subdivision, or department thereof, and to perform and carry out, assign, cancel, or rescind any of such contracts.

5 To exercise all or any of the limited liability company powers, and to carry out all or any of the purposes, enumerated herein otherwise granted or permitted by law, while acting as agent, nominee, or attorney-in-fact for any persons or corporations, and perform any service under contract or otherwise for any corporation, joint stock company, association, partnership, firm, syndicate, individual, or other entity, and in such capacity or under such arrangement develop, improve, stabilize, strengthen, or

extend the property and commercial interest thereof, and to aid, assist, or participate in any lawful enterprise in connection therewith or incidental to such agency, representation, or service, and to render any other service or assistance insofar as it lawfully may under the rights, privileges, and immunities of limited liability companies for profit.

.6 To do everything necessary, proper, advisable, or convenient for the accomplishment of any of the purposes, or the attainment of any of the objects, or the furtherance of any of the powers herein set forth, either alone or in association with others incidental or pertaining to, or growing out of, or connected with its business or powers, provided the same shall not be inconsistent with the laws of the State of Florida.

7 The several causes contained in this statement of the general nature of the business or businesses to be transacted shall be construed as both purposes and powers of this limited liability company, and statements contained in each clause shall, except as otherwise expressed, be in no way limited or restricted by reference to or inference from the terms of any other clause. They shall be regarded as independent purposes and powers.

8 Nothing herein contained shall be deemed or construed as authorizing or permitting, or purporting to authorize or permit the limited liability company to carry on any business, exercise any power, or do any act which a limited liability company may not, under the laws of the State of Florida, lawfully carry on, exercise, or do.




