**ARTICLES OF AMENDMENT TO ARTICLES OF
ORGANIZATION OF WEBB DIVERSIFIED, LLC, a FLORIDA
LIMITED LIABILITY COMPANY**

These ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF WEBB DIVERSIFIED, LLC, (the "LLC") filed January 8, 2009 with the Florida Department of State, (the "LLC Agreement"), is hereby made and entered into as of this 20th day of January, 2010, by and among all of the members of the LLC.

The Articles of Organization of said LLC are amended as follow:

1. Article I of the LLC Agreement shall be amended to provide that the principal office shall be located at 295 Rosehill Drive East, Tallahassee, FL 32312.
2. Article IV of the LLC Agreement shall be amended to provide that the LLC shall be managed by two (2) managers who shall be: Gayle Webb, whose address is 295 Rosehill Drive East, Tallahassee, FL 32312 and Katherine S. Webb, whose address is 1628 Gardenpark Lane, Tallahassee, FL 32308.
3. Article VII of the LLC Agreement shall be amended as to the members' percentages of ownership as follows:

Katherine S. Webb	17.67%
W.S. Webb, Jr.	32.33%
Gayle Webb	34.33%

4. Except as expressly stated herein, all other provisions of the original Articles of Organization of Webb Diversified, LLC shall remain in full force and effect.
