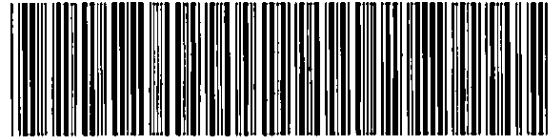

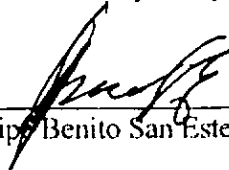
Pursuant to Section 605.0707, Florida Statutes, this Florida limited liability company submits the following articles of dissolution:

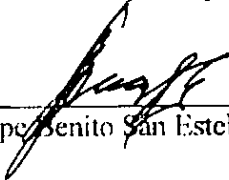
