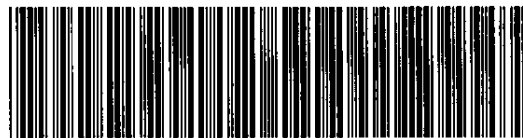

By resolution of its members and pursuant to Florida Statute 608.445 these Articles of Dissolution are hereby adopted for delivery to the Florida Department of State for filing.

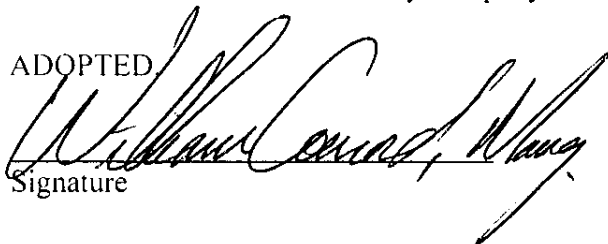
1) The name of the dissolved Limited Liability Company is:
