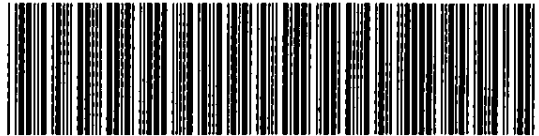

**ARTICLES OF ORGANIZATION
OF
MICHAEL D WESSON, OD LLC**

The undersigned, for the purpose of forming a limited liability company under Title XXXVI, Chapter 608 of the Florida Statutes, hereby file the following Articles of Organization with the Division of Corporations of the county in which the initial registered office of the limited liability company will be located and affirm that the facts stated in these Articles of Organization are true and correct:

ARTICLE I

NAME OF COMPANY: The name of the limited liability company is Michael D Wesson, OD LLC.
("The Company").

ARTICLE II

DURATION: The period of duration of the Company shall be from the date of filing of these Articles of Organization with the Division of Corporations for Charlotte County, Florida until the first to occur of the following:

- (1) Fifty (50) years from the date of filing of these Articles of Organization; or
- (2) Dissolution of the Company pursuant to the provisions of the laws of the State of Florida or the Operating Agreement of the Company, as in effect from time to time.

ARTICLE III

PURPOSES: The purpose for which the Company is organized is to perform any lawful purpose except that of banking and insurance.

ARTICLE IV

REGISTERED OFFICE AND AGENT FOR SERVICE OF PROCESS: The location and mailing address of the initial registered office of the Company shall be **1020 Via Tripoli, Punta Gorda, Florida 33950**. The name of the initial registered agent for service of process at the foregoing address shall be **Michael D Wesson**. Having been named as registered agent and to accept service of process for the above stated limited liability company at the place designated in this certificate, I hereby accept the appointment as registered agent and agree to act in this capacity. I further agree to comply with the provisions of all statutes relating to the proper and complete performance of my duties, and I am familiar with and accept the obligations of my position as registered agent as provided for in Chapter 608, F. S.

ARTICLE V

INITIAL MEMBERS: The names and mailing addresses of the initial members of the Company are as follows:

ADDITIONAL MEMBERS: Additional members may be admitted but only upon the unanimous written consent of the then existing members.

ARTICLE VII

CONTINUITY OF BUSINESS: Upon the death, retirement, resignation, expulsion, bankruptcy, dissolution, or dissociation of a member, or the occurrence of any other event which terminates the continued membership of a member in the Company, the business of the Company shall not be continued and the Company shall be dissolved unless there is obtained the written consent of all the remaining members of the Company within 90 day after the occurrence of the terminating event and there are at least two remaining members.

ARTICLE VIII

MANAGEMENT: A manager or managers shall manage The Company. The names and mailing address of the manager who is to serve as manager until the first annual meeting of the members or until said manager's successor is duly elected and qualified is follows:

ARTICLE XI

NO LIABILITY: The members of the Company shall have no liability for any debt, obligation, or liability of the Company, as provided in the Florida Statutes 608.407.

ARTICLE X

PRINCIPAL PLACE OF BUSINESS: The principal place of business in the State of Florida for the Company is 1020 Via Tripoli, Punta Gorda, Florida 33950.

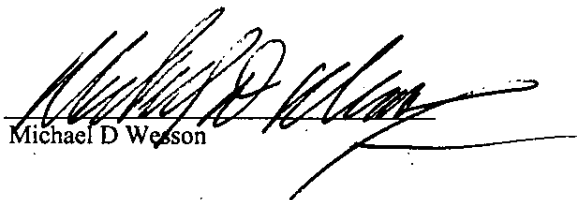
ARTICLE XI

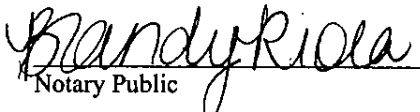

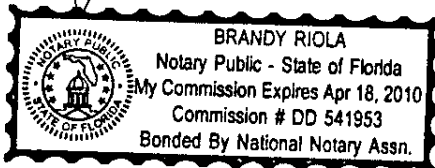
