ARTICLES OF ORGANIZATION
OF
AKKJ, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I – NAME

The name of the limited liability company shall be AKKJ, LLC (the "Company").

ARTICLE II – ADDRESS

The mailing address of the Company shall be P.O. Box 7547, Naples, Florida 34101. The street address of the initial principal office of the Company shall be 8025 Bayshore Drive, Naples, Florida 34112.

ARTICLE III – DURATION
