ARTICLES OF ORGANIZATION

The undersigned, acting in his capacity as the Manager of Teachersight, LLC, a Florida Limited Liability Company (the "Company"), on behalf of the Company, has duly executed and filed these Amended and Restated Articles of Organization pursuant to Section 608.411 of the Florida Statutes.

The Articles of Organization for the Company were filed with the Florida Secretary of State on January 14, 2009 and assigned document number L09000004193. The Company's name is presently Teachersight, LLC.

These Amended and Restated Articles of Organization amend and restate the Articles of Organization of the Company in their entirety as follows:

ARTICLE I

Name. The name of the limited liability company shall be **TEACHERSTUDIO, LLC** ("Company").

ARTICLE II

Address. The mailing address and the street address of the principal office of the Company shall be of the Company shall be 64 E. Concord St., Orlando, Florida 32801.

ARTICLE III

Duration. The Company's existence shall be perpetual unless the Company is earlier dissolved as provided in the operating agreement of the Company.

ARTICLE IV

Registered Office and Agent. The street address of the registered office of the Company is 64 E. Concord St., Orlando, Florida 32801, and the name of the registered agent of the Company at that address is GREGORY B. GALLOWAY.

ARTICLE V

Management. The Company shall be managed by a manager or managers in accordance with an operating agreement adopted by the members for the management of the business and affairs of the Company. The operating agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Amended and Restated Articles of Organization.


