#### Articles of Organization

### A Florida Limited Liability Company

- 1. Name. The name of this limited liability company is WPW, LLC (the "Company"), and it shall be formed as a Florida limited liability company under Chapter 608, Florida Statutes.
- 2. <u>Duration</u>. The Company shall exist from the date of filing of these Articles of Organization with the Florida Secretary of State, and the Company's existence shall be perpetual.
- 3. <u>Purpose</u>. The Company is organized for the purpose of transacting all tawful activities and businesses that may be conducted by a limited liability company under the laws of the State of Florida.
