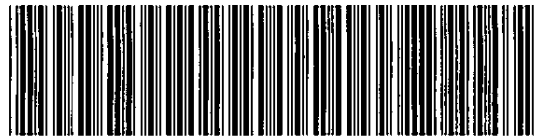


Jeon and O'Hara are not managers of the LLC. The only Managing Member as authorized by
