The undersigned, being desirous of forming a professional limited liability company pursuant to Chapter 608, Florida Statutes, hereby certifies as follows:

1. Name of Limited Liability Company. The name of the limited liability company is **CCS & ASSOCIATES, LLC** a Florida professional limited liability company (the "Company").

2. Period of Duration. The period of duration for the Company shall be perpetual.


