Article VIII**Management**

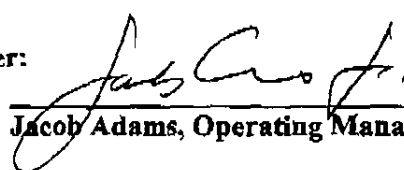
